### **Privacy Policy**

**This policy is effective as of November 1st, 2015. FULLNESS IN CHRIST MINISTRIES (FCM) is committed to protecting your privacy. This Statement of Privacy applies to the FCM web site and governs data collection and usage for all FCM sites and services; it does not apply to other online or offline sites, products or services. Please read the FCM Statement of Privacy. FCM is a general audience web site, intended for users of all ages. Personal information of all users is collected, used and disclosed as described in this Statement of Privacy.**

#### **Collection of your Personal Information**

As an E-commerce web site, FCM collects personal information, such as your e-mail address, name, home or work address or telephone number. Information collected by FCM is used solely for the purpose of billing and shipping your online purchases. FCM does not collect any information about your computer hardware and software. FCM encourages you to review the privacy statements of web sites you choose to link to from FCM so that you can understand how those web sites collect, use and share your information. We are not responsible for the privacy statements or other content on web sites outside of the FCM web site.

#### **Use of your Personal Information**

FCM and its operational service partners collect and use your personal information to process product orders and deliver the products requested. It is possible that FCM may also use personal information to inform you of other products or services available from FCM and its affiliates. FCM may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

FCM does not sell, rent, or lease its customer lists to third parties. Your personal information (e-mail, name, address, telephone number) is never transferred to the third party. We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, processing transactions, or performing statistical analysis of our services. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

FCM does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent. FCM may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on FCM or the site; (b) protect and defend the rights or property of FCM, including its web site; or (c) act under exigent circumstances to protect the personal safety of users of FCM or the public.

Personal information collected on this site may be stored and processed in the United States or any other country in which FCM or its affiliates, subsidiaries or agents maintain facilities, and by using this site, you consent to any such transfer of information outside of your country. FCM abides by the safe harbor framework as set forth by the U.S. Department of Commerce regarding the collection, use, and retention of data from the European Union.

### **Security of your Personal Information**

FCM is committed to protecting the security of your personal information. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure. For example, we store the personal information you provide on computer systems with limited access that are located in controlled facilities. When we transmit highly confidential information (such as a credit card number) over the Internet, we use a secure payment gateway so your information is protected.

### **Changes to this Statement**

FCM will occasionally update this Statement of Privacy to reflect company and customer feedback. If there are material changes to this Statement or in how FCM will use your personal information, FCM will prominently post such changes prior to implementing the change. FCM encourages you to periodically review this Statement to be informed of how FCM is protecting your information.
